While COVID-19 remains highly infectious, we are taking extra precautions with applicable local, state, and federal regulations and guidance to reduce the likelihood of the spread of COVID-19 on CCSA premises. However, even with these precautions in place, we cannot guarantee the safety of our participants. As a result, parents must complete and sign this COVID-19 Release and Waiver of Liability to participate in CCSA activities during the pandemic.

in consideration for my child(ren)'s participation in a CCSA activity, agree to routinely monitor my child(ren)'s health. If my child(ren) or any person within my child(ren)'s household or with whom my child(ren) have had close contact show any of the following symptoms within 24 hours before entering CCSA premises, I agree not to bring my child(ren) to CCSA:

- Fever
- Cough
- Shortness of breath
- Chills
- Muscle pain
- Headache
- Sore throat
- New loss of taste or smell

I understand and acknowledge my child(ren) may only participate in CCSA activities if they are free of symptoms of the novel coronavirus, COVID-19. I further understand and acknowledge if my child(ren) or anyone living within my child(ren)'s household has any of these symptoms, my child(ren) will not be allowed to enter CCSA premises until they are cleared by a doctor. I agree to notify management of any conditions or changes in my child(ren)'s health status. I agree to inform CCSA if my child(ren), anyone in my household, or anyone with whom members of my household have been in close contact tests positive for COVID-19 so that CCSA can take necessary steps and advise me on when my child(ren) may return to the CCSA premises based on CDC guidance given the specific situation. I acknowledge CCSA agrees to keep my child(ren)'s identity confidential.

On behalf of myself and my child(ren), I assume the risk and all responsibility for my child(ren)'s safety while participating in CCSA activities and assert my child(ren) is/are in good health. I, on behalf of myself and my child(ren), release and forever discharge and hold harmless CCSA, its directors, officers, employees, agents, related entities, and representatives (collectively the "CCSA Releasees") from any and all liability, claims, and demands of any kind or nature, either in law or in equity, which arise now or in the future in connection with my child(ren)'s participation in CCSA activities during the global COVID-19 pandemic. I understand and agree that this release discharges the CCSA Releasees from any liability or claim that I or my child(ren) may have against the CCSA Releasees with respect to bodily

injury, personal injury, illness, death, property damage, or any other harm that may result from my child(ren)'s participation in CCSA activities, including harm caused by the ordinary negligence of CCSA. I expressly waive any right to a trial by judge or jury that I or my child(ren) may otherwise have with regard to any claim or liability related to my child(ren)'s participation in CCSA activities. I consent to the provision of emergency medical treatment in the event of my child(ren)'s illness or injury and release and forever discharge the CCSA Releasees from any liability claim whatsoever which arises or may later arise on account of any medical service rendered in connection with an emergency during my child(ren)'s participation in CCSA activities. In consideration of and for the right of my child(ren) to participate in CCSA activities during the global COVID-19 pandemic, I agree to indemnify and hold harmless the CCSA Releasees from any and all claims, liability, actions, causes of action, debts, claims and demands of any kind or nature, either in law or in equity, which arise now or in the future in connection with my child(ren)'s participation in CCSA activities during the global COVID-19 pandemic.
